| REDMOND | 20-Aug-05 | Sat | 2:45 PM | Theft | Yes | | Patron reported that someone had stolen his pump, bag and tools from his bike when it was locked on the bike rack. I dialed 911 and the dispatcher asked to speak with him. He had to leave before the police arrived. |
| REDMOND | 11-Aug-05 | Thu | 1:00 PM | Injury/Illness | No | Used first aid kit, offered to call 911 but refused. | Woman tripped over step stool & cut her nose. |
| REDMOND | 26-Jul-05 | Tue | 4:15 PM | Injury/Illness | No | Told librarian about possible hazard of shelf to children. | Young patron bumped into the shelf protruding from the wall in the snack area. Caused a painful bruise to his neck. |
| REDMOND | 16-May-05 | Mon | 11:00 AM | Theft | Yes | Stopped patron from leaving library after he had stolen DVD's Called police. | Patron stole DVD's from library. |
| REDMOND | 28-Apr-05 | Thu | 6:05 PM | Other | Yes | Called Police. | 2 girls fighting in computer section. They broke up. Police talked to one of the girls. She is a regular patron. |
| REDMOND | 12-Feb-05 | Sat | 10:25 AM | Disturbance | Yes | 911 called | Man refused to leave after tax volunteer could not help him with his taxes. He had complex issues that the volunteer could not help with. The man got very angry. Police arrived and spoke to him and he left voluntarily. |
| REDMOND | 10-Jan-05 | Mon | 11:30 AM | Disturbance | No | Trespassed. | Male patron was trespassed on 1/11/05 after repeated incidents of sexual misconduct, being in the library while heavily intoxicated, and harassing others. |
